



## 2022 FEE STRUCTURE

Any initial or redesignating applicant submitting their online application for Magnet as of January 1, 2022, will fall under the 2022 fee structure schedule below:

- **Application Fee** – \$6,000.00
- **Appraisal Review Fee** (Fees apply to all health care organizations.)
  - Appraisal Fee
    - Based on licensed bed size (see chart below)
    - Due at time of written document submission
  - Annual Payment (year 1, 2, and 3 post-designation year) \*
    - Based on licensed bed size (see chart below)
    - Due every year on designation month
- **Change in Document Submission Fee** – \$7,750.00
  - Note: A Change in Document Submission (extension) is for one time only and the new date for submission must be within 6 months of the previously scheduled date (for Magnet-designated organizations) and up to one year for new applicants.
